It was founded on November 19th, 1989 in Ljubljana as a company for market engineering and production. The company operates in two different locations. The company's headquarters are located at Seliškarjeva cesta 36, Grosuplje and a business unit of Studio Orca with the main production and graphic studio in Stegne 3, Ljubljana.

It has been of the utmost importance for us that we constantly upgrade and update our graphic activities, as well as adapt them to demands of the market. We are constantly following the trends in the graphics industry and we are trying to ensure the highest level of product quality. Together with our products and services, we want to ensure innovation, creativity and uniqueness. Classic offset printing

It is worth mentioning, that we are among the first printing houses in South-East Europe using this technology. Along with producing high quality prints we take responsibility towards the environment, our employees and customers. Because an image forms digitally in the printing machine, there is no need to illuminate the films, which means we have a cleaner, faster and cheaper graphic process. With this technology, SILVECO does not produce emissions of dangerous chemicals into the environment, as water is not needed for the printing process. We use paints based on soy oil, which enables the print to decompose faster, which makes it employee and environment friendly. With the use of dry offset printing and recycled paper or paper with appropriate certificates we can produce an environment-friendly prints.



DIGITAL PRINTING

Digital printing - CMYK

Demands for digital prints are steadily increasing in number and deadlines are getting shorter and shorter. There are more and more orders for small quantities of prints. The best answer to these market conditions is digital printing.

Modern production line

With the help of digital printing, we can print the same prints more than once, whereby changing the content of the prints represents no problem. Our digital printing machines represent one of the most modern printing lines in Slovenia and the EU. We use the newest models, which we steadily upgrade and update with new software and additional functions and tools.

Advantages of digital printing

The consistency of colours does not decrease with amount of prints, the colours of prints are lively, and the resolution is very high. With the short time it takes to prepare the printing, we can very quickly produce the first print, so the responsiveness in digital printing is very important. Additionally, this technology enables us to produce variable prints. With the personalization, we can print the same kind of print with different texts, images or other elements.

Experience a new dimension of digital printing

We can design and produce any visual and printed form you wish. Postcards, flyers, brochures, vouchers, front pages of writing pads for your employees, business cards and more. We print quickly and the quality of our prints is exceptional.

LARGE FORMAT PRINTING

Prints in large formats

SILVECO produces prints in large formats with different materials and for different purposes. We can print on paper, self-adhesive material for internal and external use, various canvases and foils, whereby we guarantee you the highest quality of prints.

Our Products

Our line of products includes various stickers, posters, billboards, light signs, photo wallpapers, panels for advertising stands, tasting bars, tarpaulins, banners and so on. We can print different images for your car and we can also decal your vehicle.

You can specify the design of the product, the quantities of the product and the addresses you wish the product sent to. You can specify the content, dates and the ways of sending. We can finish and print a sample following your wishes and instructions. You can choose from our creative database of designs. We can also adapt and finish your own creative works.

Using dry offset printing technology and recycled paper or paper with appropriate certificates, we can actually produce a more environmentally friendly print. PEFC certified paper ensures that the wood, used as a raw material for the production of cellulose fiber and paper, comes from sustainably economical forests. Similarly, the FSC certificate ensures that the wood for making the paper is checked by an independent, international institution and that the highest environmental and social standards are complied with.

With a more friendly form of production and work processes, SILVECO represents the use of cleaner printing techniques, which are friendlier towards the environment than other providers in the graphic industry. The technology of digital printing is very different to the dry offset technique, but being environmentally friendly is their common denominator. With the appropriate combination of these two techniques, we can successfully cover the lower and higher printing presses. This accommodates the more demanding needs of our clients as well as those with a desire for shorter production deadlines. The choice of a more favourable and more appropriate printing technique depends completely on individual situation. In general, however, it is considered that printing in small prints corresponds to digital printing techniques in price, in medium circulation, dry offset printing, and in large circuits, classical offset techniques, where prints can also be made in larger formats.







Studio Orca

Besides offering a wide range of printed materials to the customers, we also offer our customers a complete graphic preparation. The graphic preparation includes design and computer break, which is provided by experienced graphic designers who are part of a successfully organized team. In addition, we take into account the customer's wishes when planning their specific project.

As a part of our graphic preparation, we encourage our designers to constantly follow the world's design trends, encourage their creativity and look for fresh ideas for design.

As far as designing is concerned, we offer layouts for virtually all kinds of printed materials, as well as just e-design of various advertisements. The company is aware of the importance of not only having the right and attractive idea but also printing it in a presentable manner.

The advantages of our company can be found in the flexibility of our workers and work processes. Due to having the production department and graphic studio at the same location, the employees on both sides can work as a team and participate in the production. This way, they have an overview into all stages of the graphic process, from the preparation for printing, printing itself and finishing. So designers and printing workers have direct contact with each other, which makes the projects run smoothly, without interruptions and complications.

CORPORATE RESPONSIBILITY

We also implement corporate responsibility directly with a responsible attitude towards the environment, which in practice means:

- Compliance with legal requirements and other regulations and environmental protection standards.
- The tendency towards continuous improvement of work processes in production and consequently reduction of negative effects on the environment.
- Long-term cooperation only with those business partners who also meet the high standards of responsible behaviour towards the environment.
- Continuous education of our employees on the possibilities of improvements in the workplace.
- Encouraging clients to promote the use of environmentally friendly materials and work processes.
- Increasing waste separation, more efficient use of all energy products.
- Reducing CO₂ emissions into the environment and minimizing water consumption.
- Optimal use of the safest chemicals in the processes of printing and finishing.
- Objective review of achieving environmental goals.

Responsible behaviour in our printing house does not affect the quality of our products or the time of production and the responsiveness of our team. All employees are informed about proper waste management. The system administrator is responsible for informing and preparing environmental policy. In our case, this is the head of the printing house. This ensures adequate modernization of environmental policy and proper implementation in practice.

FACTORS AFFECTING THE ENVIRONMENT

The main factors affecting the environment of the Silveco printing house are the following:

Waste

The work processes produce certain waste materials, liquids and materials that cannot be completely recycled. The vast majority are non-hazardous waste such as waste paper, cardboard and metals. This part of waste allows a high level of recycling and reuse. Part of the waste represents a medium risk, for example plastic packaging and conventional municipal waste. The last part is represented by the chemicals and colours that are properly stored in the printing house until they are taken over by the partner of our printing house, which has the appropriate certificate for disposing them.

Water

Most of the water consumption is used for sanitary purposes and cleaning, while the smaller part is for direct production. The vast majority of our machinery does not require water for operation, therefore making this part of the production environmentally friendly and does not affect the pollution of the water system.

Energy Products

For the heating of the printing house, a common heat station is used, which heats the whole object at the location in Ljubljana, which operates on heating oil. The fuel for commercial vehicles is oil and gasoline, forklift and all other machinery works on electricity.

Noise

The working hours of the printing house are between 8am and 4pm. The main sources of noise are printing machines and vehicles.

WASTE MANAGEMENT

In Silveco printing house, we appropriately classified all types of waste according to the system of the statutory classification of waste. We defined the place of the creation of individual waste and proper sorting in marked containers or waste bins. The result of this is not only adequate storage, but also overall quality and cleanliness, better appearance and control in production areas.





The activities we perform in the production, such as printing, folding, perforation, gluing, punching and the like, cause environmental effects. The elements of these activities are environmental aspects, which also include potential hazards for the environment.

We also defined two indirect environmental aspects; encouraging customers to purchase printed matter from recycled paper or paper with FSC and PEFC certification and environmental education.

On the basis of three criteria (legal requirements, public and client opinion, economic impact) from all environmental aspects, we have identified the relevant environmental aspects that we will focus on in our environmental management system. We have set overall goals in the following areas: reducing CO_2 emissions, reducing water and electricity consumption, and reducing waste from production (mixed municipal waste and waste paper).

The relevant environmental aspects of Silveco are as follows:

- Emissions to air,
- Electricity consumption,
- Water consumption,
- Waste Prevention,
- Production and disposal of hazardous waste (in case of emergencies),
- Encouraging customers to purchase printed matter from recycled paper or certified paper.

Production and disposal of hazardous waste

Hazardous waste is generated in the production processes of printing (organic solvent, contaminated packaging, contaminated cleaning cloths) and preparations for printing (printing developer), but also through office activities (waste batteries and lamps, waste cartridges and toners, waste paper).

The hazardous waste generated by the press and the preparation for printing is being sent to an authorized collector, namely Komteks, with whom we have a cooperation contract. You can view the scanned Contract at the end of this brochure. There is very little residual waste, which is why we leave it to the company Snaga from Ljubljana.

Encourage customers to purchase printed matter from recycled paper or certified paper

Throughout the course of our work, we encourage our clients to make more environmentally friendly design and printing on more environmentally friendly paper. With the appropriate design and assembly of printed matter on the printing form, it is possible to optimize the amount of material used in the printing (a smaller colour application and an appropriate printed matter format).



EMERGENCY SITUATIONS PRESENT:

- Fire,
- Electric shock,
- Natural disasters,
- Accidents at work,
- Spillage of hazardous substances.

At Silveco, we identified as many possible factors, which could cause the aforementioned emergencies, and at the same time determined preventive measures to avert or at least limit their occurrence.

Factors:

- Lightning or short-circuits of electronic equipment, cables.
- Failure to follow internal instructions.
- Failure to follow directions for handling hazardous substances and materials.
- Failure to observe the safety instructions at work.
- Failure of a fire alarm system.
- Spillage of hazardous substances or fuel oil into the production hall or into the sewer.

Preventive measures:

- Implementation of instructions.
- Additional training for all employees.
- A practical test of fire extinguishing by employees.
- Practical test in case of spillage of dangerous substances.
- Proper maintenance of all means of production.
- Overview of the existing situation and definition of the measures.
- Fire protection and automated fire alarm.
- Physical security.
- Environmental monitoring.



STATISTICS MANAGEMENT

Based on the monitoring and compliance with environmental and occupational safety requirements, Silveco operations can be properly aligned with legal and other regulations in this field. Silveco is also involved in the annual submission of the report to the Statistical Office of the Republic of Slovenia, thus obliging us to report the real state of the generation of waste. At the same time, it is the reason for a transparent overview of reports and notes on their creation and appropriate storage.

COMMUNICATION

Silveco also plays a major role in communication. With this we mean both internal communication and external communication with business partners, clients and suppliers. Internal communication with employees takes place at during work or at daily meetings.

External communication contributes to the reputation of the organization and, in addition, enables us to understand our activities and the attitude towards the environment to the wider public. A lot of information about our company is available at www.silveco.com.





Splošni opis modela S.BON AJPES


